



We have openings at the Jewish Community Center for **Camp Nurses** in our 2016 Summer Day Camp program. These seasonal positions are available at both of our locations, Creve Coeur and Chesterfield. Camps run for 11 weeks, May 31th to August 12th. Our caring and enthusiastic camp nurse is the health manager for the camps, supervises health and cleanliness standards, works with camp directors and staff; and helps provide adequate physical health conditions for all. Hours for this position are 9:00am to 2:45pm Monday-Friday during camp.

Duties include:

- Attend mandatory staff orientation and Parents' Meet and Greet on May 22nd & May 24th-May 27th.
- Supervise health care needs for campers and staff during camp hours.
- Supervise all delivery of medications during camp hours
- Assist Camp Director in training staff
- Ensure each staff member and camper has on file a health history and examination form
- Conduct regular inventory of supplies and place orders proactively to ensure timely arrival with Day Camp Director approval.
- Establish and follow appropriate medical routines including record-keeping in the daily medical log, disposal of medical waste, managing and safeguarding medications, and utilizing approved standing orders
- Maintain regular parent communications
- Provide quality customer service at all times
- Check and issue first-aid kits to all camps and specific areas within the camps
- Maintain a clean and orderly Health Center (nurse's office)
- Keep accident/incident reports used for risk-management in coordination with Human Resources.
- Prepare summary and evaluation of the camp season including inventories and camper and staff reports on health problems, and make recommendations for following season
- Monitor/evaluate camp procedures, facilities, and conditions and suggest modifications that would create more healthy conditions in the camp
- Other duties as assigned by supervisor.

Desired Qualifications:

- Must hold current Missouri license as a Registered Nurse
- Experience with children and young adults is required, camp experience preferred.
- Ability to originate, update, and/or monitor health care, maintain records, and implement the health care plan is required.
- Ability to provide guidance, supervision, and engage with children in an enthusiastic manner is required.
- Ability to assist campers in emergency situations, including fire, evacuation, illness or injury is required.

- Good character, integrity and adaptability are necessary.
- Enthusiasm, sense of humor, patience and self control are necessary.
- Current CPR, First Aid and AED certifications are required
- Desire to work in a camp community is necessary.
