



We have openings at the Jewish Community Center for Substitute Teachers at our Chesterfield and Creve Coeur locations. Several positions are available and hours are on an as needed basis. Opportunities abound to cover the occasional absence as well as to cover vacations.

Overview:

The J's Early Childhood Program is accredited by the State of Missouri and licensed by the Missouri Department of Health and Senior Services. We use the Project Construct Curriculum Framework and focus on character-development, value-driven programming for our students. We provide care for children ages 6 weeks – 5 years of age in a safe, warm, nurturing environment that helps children feel good about themselves and the world around them. Our program operates from 7am to 6pm, Monday - Friday. Applicants should have flexibility to work within our operating schedule.

Responsibilities:

- Set up, take down, and clean classroom as necessary.
- Maintain a safe environment for the children at all times.
- Assist and or lead activities for the children following the lesson plans for the week.
- Follow all Missouri licensure and JCC guidelines in the course of your work.
- Perform anecdotal record keeping, for example, daily observations, injury reports, parent inquiries, etc.
- Communicate professionally with parents and coworkers. Maintain a professional attitude at all times.
- Communicate and interact appropriately with children
- Attend in-service workshops, conferences, staff meetings, and special events as required.
- Earn 18 continuing education credits per year.
- Incumbent in the position is required to become First Aid and CPR certified upon hire (training provided) and certification must be kept current.
- Maintain a neat and clean appearance
- Be punctual and maintain good attendance
- Other duties as assigned by supervisor

Preferred Qualifications:

- College degree in Education or related field
- Prior experience working with children
- Prior education experience
- Training and experience using the Project Construct Curriculum Framework

Minimum Qualifications:

- Minimum age of 18
- High School Diploma (or GED) required.
- A minimum of nine (9) college credit hours in early childhood, child development, youth development or child/family related courses.
- Must be proficient with computers, including Microsoft Office Suite (Outlook, Word, Excel, PowerPoint, Access)
- Strong written and oral communications skills

- Demonstrated customer service skills
- Demonstrated ability to work within a team environment
- Must possess strong organizational skills and ability to multi task in a dynamic environment.
- Able to physically stand, walk, bend, stoop, kneel and lift children up to 50lbs.
- Able to accompany children outside to playground, to gym class, and to swim class (teachers are in the water)

Teachers are required to become registered with the MO Family Care Registry. Active registration must be maintained for employment at our center. Annual TB testing and current Hepatitis A vaccinations are required per state regulations.
